LICHTENBURG SE VOORSTE VROUW IN EIENDOM

VROUW SE KOOPKRAG HERVORM SA EIENDOMSMARK

Daar was 'n bestendige toename in vroue se koopkrag in die residensiële eiendomsmark, volgens data wat deur Leadhome ontleed is.

Marcel du Toit, uitvoerende hoof van Leadhome, sê dit is besig om die Suid-Afrikaanse eiendomsmark, wat tradisioneel deur mans oorheers is, fundamenteel te hervorm.

Veral swart vroue is 'n belangrike marksegment, volgens Hayley Ivins-Downes, van die eiendomsontledingsfirma Lightstone.

Leadhome se data toon dat vroue 45% van alle eiendomsregistrasies uitmaak terwyl 7% gesamentlike registrasies is.

"Vandag is daar meer vroue in die werkplek as ooit tevore, en hulle koop huise – ongeag die grootte van hul salaris," sê Du Toit. "Selfs wanneer hulle uiteindelik saam met hul vennote koop, of in hul maat se name, dui die data daarop dat vroue toenemend invloed en besluitnemingsmag het, benevens koopkrag."

Hy sê baie jong vroue beskou die koop van eiendom as 'n belegging en 'n geleentheid om vroegetydig rykdom op te bou.

Meer vroue is eerskeer huiskopers in Suid-Afrika as mans, volgens Ivins-Downes, van die eiendomsontledingsfirma Lightstone. Dit was reeds die tendens die afgelope ses jaar.

Eerste keer vrouekopers het in 2018 'n hoogtepunt bereik met net minder as 43 000 (39%) uit 'n totaal van 109 816 – en ver voor die mans se totaal van 32 600 (30%). Maar terwyl enkelopende vroue meer eiendom koop as enige ander

kategorie kopers, is vroue tipies agter beide veelvuldige kopers en enkelopende mans wanneer dit kom by die gemiddelde huisprys.

Die data toon verder dat die gemiddelde prys wat vroue vir eiendom betaal net R500 000 is, in teenstelling met die kategorie vir getroude paartjies en enkelopende mans waar die gemiddelde prys net minder as R600 000 is; veelvuldige kopers het vanjaar gemiddeld nagenoeg R770 000 bestee.

Die laer aankoopprys vir vroue kan die laer verdienvermoë van vroue weerspieël wat vandag nog algemeen voorkom en kan ook 'n aanduiding wees van die aantal enkelma's, volgens

Ivins-Downes.

Alhoewel vroue begin huise koop voor 20 jaar oud is daar 'n byna 400% sprong van die 21 tot 25 ouderdomsgroep na die 26-30 ouderdomsgroep, met verkope aan vroue wat 'n hoogtepunt bereik in die 31 tot 35 ouderdomsgroep.

Daarna is daar 'n geleidelike afname in die aankoop van huise namate vroue ouer word. Dit volg wel die patroon van grootmaat-eiendomaankope wat plaasvind wanneer verdienste styg en wanneer gesinsbehoefes ter sprake kom.

Terwyl verkope aan vroue in boedels en deeltitels betreklik konsekwent gebly het oor die afgelope vyf jaar, is vrye eiendom verreweg die gewildste – 'n tendens wat oor kategorieë en waardebande heen gesien word.

Die meeste huise is in Gauteng en Wes-Kaap gekoop, waar die meeste verkope in bekostigbare gebiede en nuwe ontwikkelings aangeteken is, wat die siening ondersteun dat vroulike huiseienarskap vinnig in hierdie marksegment versprei, volgens Ivins-Downes.

Verbande

Meer vroue doen aansoek om verbande en verdriedubbel die aantal wat verbande toegestaan word, as wat 10 jaar gelede gesien is. In die laaste dekade het die aantal BetterBond se aansoeke van vroue met 12% toegeneem, met 40% van alle aansoeke wat vanjaar ontvang is van vroue. Ook in 2010

was slegs 14% van verbandtoelae vir vroue, en nou staan dié getal op 41%.

"Terwyl daar steeds 'n geslagsloongaping in Suid-Afrika is – mans verdien na raming 35% meer as vroue om dieselfde werk in sommige beroepe te doen – is dit bemoedigend om die aansienlike groei in verbandtoelae vir vroue te sien," sê Jenny Rushin, BetterBond se nasionale ontwikkelingsbestuurder. "Met die huidige uitlenomgewing en rentekoerse op historiese laagtepunte, is eiendom nou selfs meer toeganklik vir vroue."

Verlede jaar was 60% van BetterBond se aansoeke van vroue en enkelopende vroue.

Victor Frank het dit jare gelede toe hy in 'n Duitse konsentrasiekamp gesit het, eerstehands geleer. Hy skryf in sy boek: Man's Search for Meaning, dat dit hom aan die lewe gehou het. Hy waarsku dat mense te dikwels gekaap word deur dit wat met hulle gebeur in plaas daarvan om dan eerder beheer te neem van hulle emosies.

Anthony Robins skryf ook in sy boek, Awaken the Gaint within, dat 'n mens elke emosie wat jy beleef doelbewus moet kies.

So eenvoudig is dit dan – die emosie wat ek beleef het ek self gekies!!! As ek nie 'n bepaalde emosie wil beleef nie, kies ek net 'n ander emosie! Moenie dat jou emosies jou beheer nie, nee, beheer jy eerder jou emosies.


